Precision Design uses the standard warranty in the industry: We will support the dealer with electrical or stainless steel parts for the full warranty period. All parts may be ordered from the factory or the dealer can use parts from their own stock to repair the distiller. The defective parts are then returned to the factory for warranty replacement or credit. Dealers must contact the factory for a return authorization number prior to returning the parts. Once the parts are received at the factory, the factory will inspect the parts and inform the dealer if approved for credit, replacement or repair. The dealer is responsible for freight costs occurred for returning defective parts, replacement parts or repaired parts.

Labour to replace the part is to be covered by the dealer, whether in the home or in the dealer's place of business. Your current pricing structure allows for the possibility of repairs to distillers under warranty.
